



ADOPTED CONSTITUTIONAL CHANGES

The following changes were submitted after a review by the Constitution Committee. They were read before the General Membership Meetings on October 13, 2018 and February 9, 2019. They were read again, discussed, and were voted on and adopted at the April 13, 2019 General Membership meeting.

Newly changed items in each section are listed in **BOLD ITALIACS** fonts.

Changes are listed by their Proposed Number. — **0**—

The following change added the position of Assistant to the Secretary-Treasurer as an appointed position. This position was added to Article 7 as Section 4, and all subsequant articles were renumbered as needed to keep it in procimity to the Secretary-Treasurer position.

Article 7, Section 4

ASSISTANT TO THE SECRETARY-TREASURER:

- (A) The Assistant to the Secretary-Treasurer under the supervision of the General President, shall assume the duties of the General Secretary-Treasurer in cases of their absence or inability to attend to any or all duties of the office of the Secretary-Treasurer. They shall be authorized to sign checks in the absence of the Secretary-Treasurer.
- (B) He/she shall be appointed by the General President. He/she shall work at the direction of the General President and they shall perform all other duties that may be delegated to them by the General President.
- (C) When it becomes necessary for the Assistant to the Secretary-Treasurer to assume the duties of the Secretary-Treasurer, they shall receive a salary of \$190.00 per month.



The following change added additional duties to the position and changed the title from OWCP Director to Human Relations Director. This section was renumbered from Article 7, Section 11 to Article 7, Section 12 (see above)

Article 7, Section 12

HUMAN RELATIONS DIRECTOR:

There shall be an appointed position hereinafter called *Human Relations* Director. The *Human Relations* Director shall be responsible for the education of a" stewards and members concerning OWCP issues, *civic, community service, and all other related programs.* He/she will be responsible for handling issues concerning members' claims, when requested. He/she shall work at the direction of the Local and/or National President of the APWU. Their salary shall be \$94.00 per month plus authorized lost time shall be paid.



The following change added a third category of membership, for definition purposes only, for members who retire from USPS employment and continue paying full membership dues and taxes at the same FTR rates. This section added Article 3, Section 3(C) and renumbered the former Article 3, Section 3(D)

Article 3, Section 3

MEMBERSHIP AND DUES

- (A) There shall be three (3) categories of members in this Local.
- (B) Active membership shall be any person employed in a non-supervisory position under this Union's jurisdiction.
- (C) Members of this union who retire from employment in an APWU bargaining unit may maintain full membership with all rights of such membership by continuing to pay full per capita taxes to the APWU plus whatever local dues may be required by their local union. It shall be the responsibility of the retiree to pay per capita and dues to the appropriate agency. They shall retain the same right to vote in all matters they had immediately before retiring from service.
- (D) Associate membership shall be for Federal-Classified, EAS, Mail Handler, Carrier, Rural Carrier and tribal or tribal organization Employees. They may be accepted as Associate Members for Health Plan participation only and receive official publications. They shall pay thirty-five dollars (\$35.00) per annum for this privilege, five dollars (\$5.00) of which shall go to the local in the area where the Federal-Classified, EAS, Mail Handler, Carrier, Rural Carrier or tribal or tribal organization employee is employed.



The following change added responsibilities to the Membership/Insurance Coordinator, formerly Article 7, Section 4 and renumbered to Section 5 (see Article 7, Section 4 above) to provide for Election Voters are accounted for to the Election Committee previously only in Article 10, Section 6, now duplicated in Article 7, Section 5.

Article 7, Section 5

MEMBERSHIP/INSURANCE COORDINATOR:

- (A) The Membership/Insurance Coordinator shall work in conjunction with the General Secretary-Treasurer. They shall be responsible for reviewing the dues checkoff reports and with the Secretary-Treasurer ensure the proper dues are being collected. They shall furnish the General Secretary-Treasurer, Editor of the official Union paper, and the membership with a monthly report showing numbers of members by craft, non-pay status, non-career, non-members and showing by name new members cash pay, honorary, and cancellations. They shall be a member of the Budget Committee.
- (B) At the Triennial Election, the members of the Election Committee shall be provided by the Membership/Insurance Coor-



dinator, a complete list of members in good standing who are eligible to vote (Refer to Article 10, Section 6).

- (C) The Membership/Insurance Coordinator shall have the responsibility of processing and advising all members of the IALAPWU in regards to the Hospital Plan and other APWU plans. They will represent the Union at all Postal Orientations for new employees represented by IALAPWU. They will participate in Health Fairs with the goal of signing new members into the APWU Health Plan. They will participate in membership drives sponsored by the Union.
- (D) He/she shall be elected by the general Membership. They shall work at the direction of the General President and they shall perform all other duties that may be delegated to them by the General President.
- (E) Their salary shall be \$213.00 per month.



The following change eliminates the Chief Trustee, First Trustee and Second Trustee from the Executive Board after the current term of office. Trustees will still be elected, but will not serve on the Executive Board with the 2020 election. This change was made at the request of the APWU National, to aleviate possible conflict of interest issues. This change will be effective with the 2020 Election.

Article 6, Section 1

EXECUTIVE BOARD

The Executive Board shall consist of the General President, Executive Vice President, General Secretary-Treasurer, Membership/Insurance Coordinator, Recording Secretary, Clerk Craft Director "A", Clerk Craft Director "B", Clerk Craft Director "C", Clerk Craft Director "D", Maintenance Craft Director, Motor Vehicle Craft Director, and Sergeant-At-Arms.



After renumbering Article 7, Section 9 to Article 7, Section 10, the following change was made after an ammendment to add approval of the Executive Board. This change limits paid leave for training at state and national seminars and conferences to 40 hours per year for officers and stewards. It still does not allow for paid leave for State or National Conventions. An additional change was made to Article 7, Section 10 (See #8)

Article 7, Section 10

GENERAL OFFICERS/STEWARDS

(A.) Subject to the approval of the General President and approval of the Executive Board, each general officer or steward shall be entitled to be paid leave of their choice, if such time is spent on the business of the Local and shall be limited to forty (40) hours per calendar year for national and state conferences or seminars, plus all necessary expenses. Leave will not be paid for the National and State Conventions. Officers and stewards must submit a 3971 to the General President for authorization of official union business prior to compensation. All general officers shall be elected by the General Membership and all stewards shall be appointed by the General President.

(B.) Members who do not use leave in the performance of approved union business will be paid a stipend of \$50.00. Time cards must be used to account for time and is subject to approval by the General President



The following change was made to eliminate unused committees listed in the constitution. The removed committees were: Human Relations Committee, Membership Committee and Automation Committee The current committees are listed below.

The following change was made to add direct deposit as a method of payment for salaries and to reduce the frequency from monthly to bi-monthly with the exception of the President. An additional change was made to Article 7, Section 10 (See # 6)

Article 7, Section 10

GENERAL OFFICERS/STEWARDS

(C.) The General President Salary will be paid bi-weekly on the same date as the Postal Service pay date, and General Officers and Stewards will be paid on a bi-monthly basis. Salaries may be paid by check or direct deposit.



The following change changes the reference from Lost Time or LWOP to compensation in lieu of lost time referenced in the job descriptions in Article 7, and applys to retired full dues paying members serving in the local in officer positions.

Article 7, Section 13

RETIREES COMPENSATION

Any retired full dues paying member *holding an Officers position* (election or appointed) *shall be paid "other compensation"* at Level 6 Step O *in lieu of lost time in their job description.*
